The site extends to 49ha in total although not all of the site is capable of accommodating development. A part of the site identified on the attached location plan is within the airport public safety zone (psz). In addition to housing, the site could deliver the extent of public open space identified as a principle in the current Broadland Site Allocations DPD.

The site would deliver a range of high quality market and affordable homes together with associated facilities and the extent of public open space envisaged in the current Broadland Site Allocations DPD.

Site is bounded to the south by land leased to Hellesdon Parish Council originally to be used for allotments. A number of field hedgerows exist on the site which could be incorporated and enhanced in the development of the site.

There are no listed buildings on the site and the site does not lie in a Conservation Area.

**7h. Neighbouring Uses:** What are the neighbouring uses and will either the proposed use or neighbouring uses have any implications?

The site relates well to the existing built up area of Hellesdon with its southern boundary lying contiguous with the existing residential area served by Cottinghams Drive and Sadler Road. Arden Grove Infant and Nursery school is located adjacent to the south western corner of the site.

Existing allotments occupy land adjacent to the south-eastern corner. A strip of land along the southern boundary of the site is leased to Hellesdon Parish Council for community uses. We understand that the parish council's original idea was to use the land for an extension to the allotments.

The northern extent of development would be defined by the southern boundary of the airport public safety zone (psz) indicated on the plan. Although the area within the psz is inappropriate for substantial forms of development, the land could be incorporated as an area of substantial open green space.
