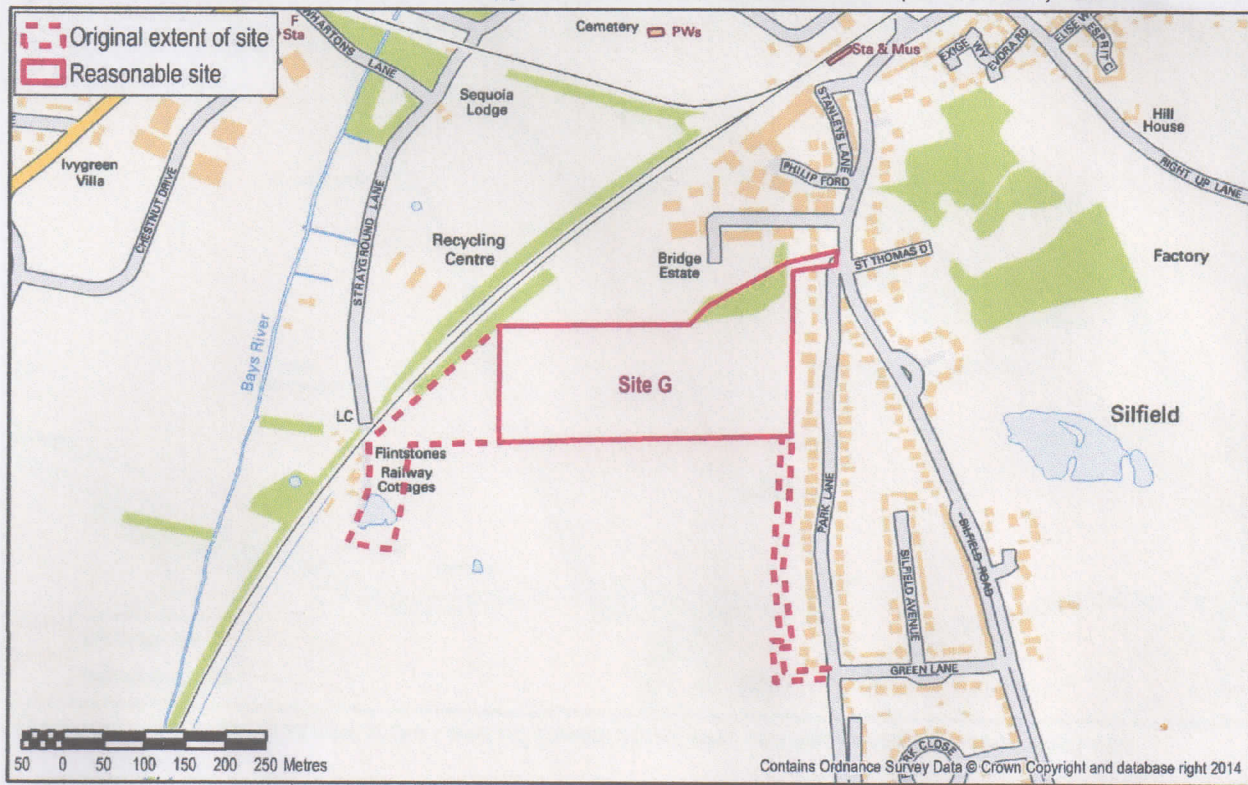


Figure 10.3: The original extent of the Strayground Lane site, and the revised ('reasonable') site
