The site extends to 4.8ha. Although the final number of homes will emerge from a more detailed design process at an average density of 20-30 homes per hectare, the likely capacity of the site can be assumed to be between 96-144.

The site would deliver a range of high quality market and affordable homes together with associated facilities. The development would also provide an appropriate contribution towards green infrastructure, children's play, sports and community facilities.

Site lies adjacent to Canham's Hill County Wildlife Site. Development on the site would respect and enhance the importance of the CWS.

There are no listed buildings on the site and the site does not lie in a Conservation Area.

The site is bounded to the south-west by existing dwellings in Bradshaw Road and to the north-east by the well treed area known as Canham's Hill. The site relates well to the settlement of Drayton with a public right of way linking it to the established built up area of Drayton and vehicular access to be created off Reephram Road.

The development would need to ensure a high quality design which would respect the amenities of existing residents and the ecological value of Canham's Hill.
