At this stage, we are purely promoting the principle of using the site for storage and distribution purposes. This submission is seeking to flag and improve the potential to deliver a well positioned development that will benefit the local economy of the Greater Norwich area.

The site offers a deliverable block of land which benefits from a suitable situation in relation to storage and distribution uses. It also benefits from a vehicular access which could service a prospective development subject to some highways works. Given the sites relative vicinity to the Loddon industrial estate, it provides an opportunity to further expand existing commercial operations to the south of Loddon without detrimentally impacting the current traffic situation.

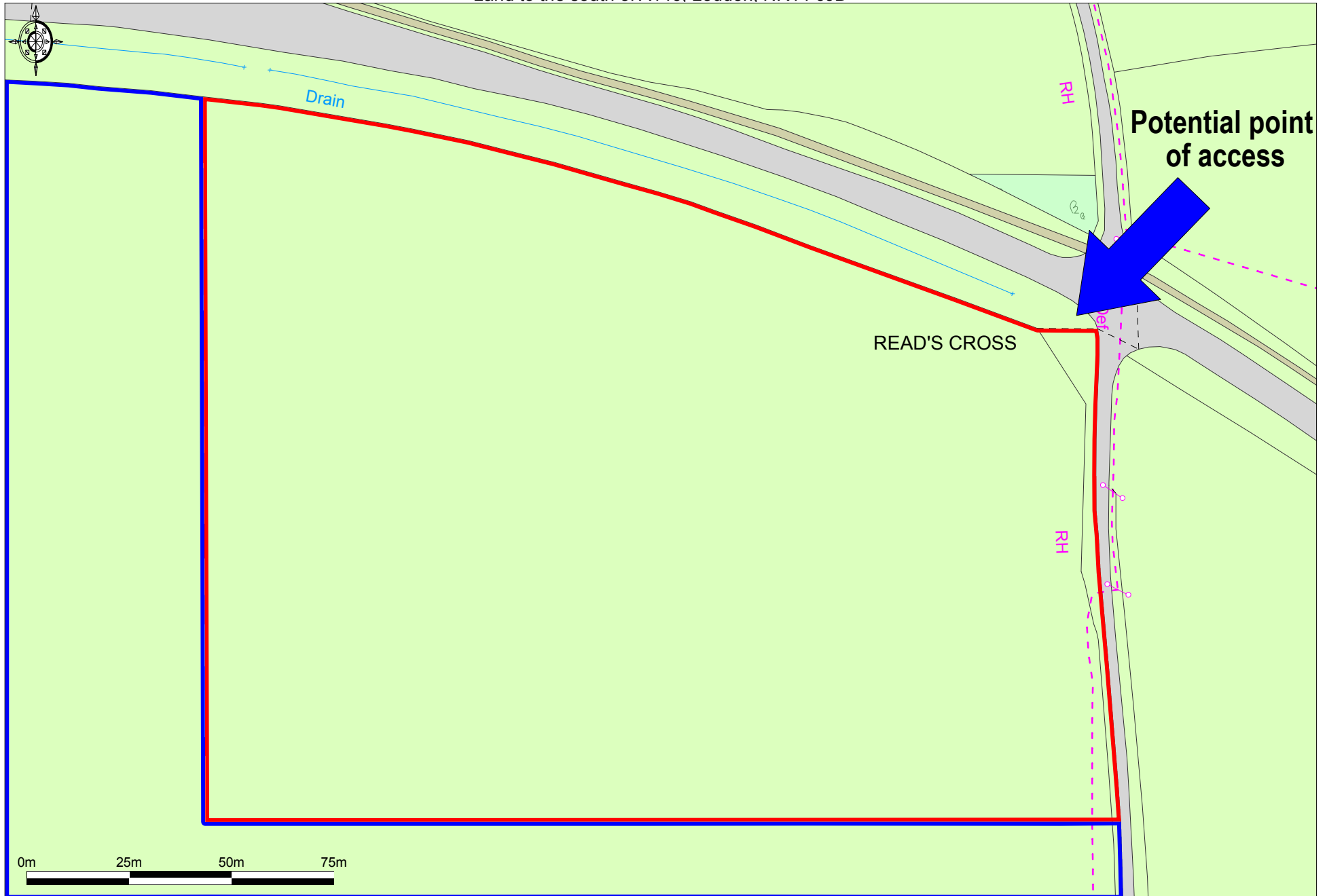
