



The site adjoins Hainford Hall, where the previous use as a car breakers has ceased, with, we understand development being proposed and consider that our clients site would complement that area, as well as providing relevant access.

It would also reflect the requirement for further development land and have regard to Hainford being an expanding residential community, situated a short distance to the north of the city of Norwich, well placed for both the airport and also the northern distributor road which is currently under construction.
