Commentary on delivery forecast

Norfolk Homes remain committed to the delivery of the site. Despite the recently issued guidance from Natural England on Nutrient Neutrality, Norfolk Homes intend to complete all plots to slab level before 15 June 2023. This will enable the site to benefit from the transitional arrangements related to the forthcoming changes to the building regulations. Such work is likely to take around a year to complete.

Norfolk Homes are of the view that they would need to review the commitments set out above if no progress towards a local authority led solution to the Nutrient Neutrality issue within 6-7 months.

Notwithstanding the above, due to the ongoing progress with the construction of the site, Norfolk Homes continue to take the view that first occupations would be seen 12-18 months from the start date and would intend to build at around 25 units per year. This is reflected in the delivery forecast set out above.
