In terms of site size, the Greater Norwich councils are inviting submissions of all sizes, but sites should be big enough for a least one pitch – which is able to accommodate a touring caravan, with a static caravan, and a small amenity block.

A separate form must be completed for each site that you wish to put forward for consideration. If you are jointly submitting a site with other people, please endeavour to submit your site only once, with all promoters named.

Each submission should include the following information as a minimum:

- A completed form for each site; and,
- A map that clearly identifies the boundaries of the proposed site on an OS base and at a scale of no less than 1:2,500.

In all instances sites should only be submitted where it is clearly demonstrated that the site can be developed before 2038.

Please note that the contents of this form will be made available for public scrutiny, and that by submitting a response form you are acknowledging that details contained in the form will be published in the public domain. Respondents should avoid including any individual personal data, such as private addresses, contact details and signatures, except where necessary to complete this site submission form.
