Thank you for consulting Historic England on the Greater Norwich Local Plan Gypsy and Traveller Sites Additional Sites Focussed Consultation. As a statutory consultee, our role is to ensure that the conservation of the historic environment is fully integrated into planning policy and that any policy documents make provision for a positive strategy for the conservation and enjoyment of the historic environment.

Please also see our detailed comments in the attached table. We provide a summary of the main comments below.

We have no comments on the Hevingham favoured site.

For the site at Foulsham, if further consideration is given for potential allocation, then we would recommend a Heritage Impact Assessment is prepared to inform the suitability of the site and policy wording due to the proximity of designated heritage assets.

For the site at Guestwick, whilst there are some designated heritage assets nearby, the site is quite well contained and intervening landscaping should limit the impact on the historic environment.

In preparation of the local plan, we encourage you to draw on the knowledge of local conservation officers, the county archaeologist and local heritage groups.

Please note that absence of a comment on a policy, allocation or document in this letter does not mean that Historic England is content that the policy, allocation or document is devoid of historic environment issues. We should like to stress that this response is based on the information provided by the Council in its consultation. To avoid any doubt, this does not affect our obligation to provide further advice and,







potentially, object to specific proposals, which may subsequently arise as a result of this plan, where we consider that these would have an adverse effect upon the historic environment.

Greater Norwich Local Plan Gypsy and Traveller Focused Consultation – 30th January 2023 to 20th March 2023

National Highways' welcomes the opportunity to provide comments on Greater Norwich Local Plan Gypsy and Traveller Sites Focused Consultation. We recognise that this document sets out the requirement for Gypsy and Traveller accommodation needs through site allocations in the plan in accordance with paragraph 68 of the National Planning Policy Framework.

National Highways' operates and manages England's Strategic Road Network (SRN). Within the Greater Norwich area this includes the A47 which will be the focus of our comments. The evidence base identifies the need for 53 residential pitches to be provided over the plan period in the Greater Norwich area. The document identifies 10 favoured sites, providing 62 pitches, along with a reasonable alternative site which could provide 10 pitches. Whilst National Highways' does not object to the overall principle of delivering of additional residential pitches, National Highways **object** to the inclusion of the following site allocation.

Policy GNLP5014 – Land off A47 North Burlingham Junction

It is noted that the document identifies a 2.48ha parcel of land available to be allocated for approximately 15 residential Gypsy and Traveller pitches. The site is located adjacent to the A47 within immediate proximity to the A47 Blofield to North Burlingham Major Development scheme. The Development Consent Order was granted in June 2022. Through the DCO, this parcel of land has been identified as required for the development and will be acquired through the order and will be in the ownership of

National Highways. As a result, we object to the inclusion of the site as an allocation as the site will not be available for the proposed development.

I have attached a plan to this submission identifying the area of land which will become owned by National Highways. Please find a snapshot below for ease of reference. The pink land identifies the land which become owned by National Highways. Through the DCO, the area of land will require some trees to remain and a proportion of the draft allocated land to be part of the environmental mitigation and an attenuation pond. It is therefore National Highway's view that the land in question would not be available, nor capable of providing the requisite number of pitches, identified within this document.

I trust this response will be helpful and will help to inform the next stages of the plan's development. If, however, you require any further information, please do not hesitate to contact me. I look forward to receiving confirmation that our comments have been received in due course.



Planning for GNLP 5025, 5026, with reference to GNLP 5022

Introduction

Representing: a group of local residents, living on Reepham Road, with serious concerns about expansion of provision of gypsy and traveller sites in this immediate area.

In this road there are already 3 gypsy and traveller sites, with plans for expansion. With the inclusion of Guestwick Green, we feel this is out of balance with the size of the existing community.

Background

Our experience between 2008 and 2023 in relation to The Oaks is important in the context of this current discussion about the new proposals.

We have been alarmed at the existing and proposed expansion at The Oaks, which we understand has now been granted. We have been particularly concerned about lack of communication from the Council, with local residents finding out about the proposed expansions only through the local paper and word of mouth. This will be the subject of a separate complaint.

The Oaks remains a site of concern for us in the following ways and these issues should be considered when the new sites are under discussion:

- 1. The current impact on the local community, in relation to its increased size, particularly in relation to traffic movement and pressures on an already fragile infrastructure;
- 2. There has been no evidence of any adherence to the original plans and limitations and an apparent complete lack of any scrutiny of the unauthorised expansions. (From 2 pitches to 5 pitches judged by the number of rubbish bins and the way that the development has covered the whole field. And now to 10?). 10 pitches requires space for 20 cars, 20 mobile caravans and 10 static caravans;
- 3. The additional new unauthorised entrance;
- 4. Already significantly increased vehicle movement;
- 5. It is with this experience, we have little or no confidence that the Council will increase its oversight of future sites and ensure that planning restrictions are observed. As an example, one of the restrictions that the traveller site should be 'absorbed into the wider landscape' has been very clearly disregarded.

The Woodyard

Permission was given in 2012 for 2 pitches, on appeal. We understand that 2 further pitches are now proposed. However, on Page 3 of the New Gypsy and Traveller Sites Addendum it proposes in Table 2 (see below) that there should be provision of a total of 6 pitches. This ambiguity needs to be clarified.

We believe this site, with provision for 2 pitches is already at full capacity, in the knowledge of the amount of space each pitch requires, allowing for vehicles to park and to turn, and the dangerous position in relation to the road, which has been described as an accident blackspot.

The proposal for 4 pitches on this site, allows for 8 cars, 8 touring caravans and 4 static caravans. This site is clearly not big enough to accommodate these and the restrictions to traffic movement in and out of the approved entrance already in place for 2 pitches would be insufficient for 4 pitches.

Highways

- 1. Original refusal included concerns about the Brandhip Corner and its dangers. At the Planning Inspectorate meeting (22 February 2012) it was emphasised that the eastern entrance should be permanently blocked because of Highways' concerns. They also insisted that space within the site for vehicles to park and turn must be provided and that to ensure the eastern entrance would not be taken back into use, 'vehicular access can only be taken from the northern entrance'. We note that in the last year the eastern entrance has been opened up and development has taken place within the site. We understand part of the site has recently been sold.
- 2. Since 2012 and the safety concerns expressed then, there has been a major increase in the amount of traffic using Reepham Road, and at speed, also including school buses and agricultural vehicles. It is important to remember that the national speed limit of 60mph applies up to, and including, the bend at Brandhip corner.
- 3. There have been several collisions at Brandhip corner, including a police vehicle, and more anecdotal evidence of near misses.

Foulsham Parish Council Cont.

- 4. This is a popular cycle route providing a route to the Marriott Way (National Cycle Route 1).
- 5. There are no pavements or verges or spaces for pedestrians or cyclists to escape traffic at this point.

Environmental and Safety concerns

- 1. Lorry loads of mixed hardcore have been delivered and spread over the existing site with ground level being significantly increased.
- 2. There is already an issue with run-off at this point in the road. As this site is sloping, surface water run off containing any contaminants will naturally run into the local water courses.
- 3. Provision was made in the 2012 Planning Inspectorate Report to protect the Oak tree from any installation of hard standing and impact on tree roots. Expansion of the site will restrict possibility of protecting the tree. In fact it appears that the base and surroundings of the oak tree has already been encroached by hardcore.
- 4. Have the boundaries with the County Wildlife Site, noted in 2012, been taken into consideration with this proposed expansion?

Guestwick Green

This is a small and very rural hamlet, with no local transport or amenities and is situated within a network of small lanes. With the prior experience of the expansion at The Oaks there is a concern that the proposal of a site for 3 pitches will create an imbalance within this small community. With 3 pitches, 6 cars and 6 touring caravans and 3 static caravans there will undoubtedly be problems with traffic.

Highways

- 1. The narrow lanes surrounding Guestwick Green make it unsuitable for any increase in traffic.
- 2. Its position on a tight bend make it potentially dangerous.
- 3. There are no pavements or verges and there is a deep ditch on the one side of the road. Space for pedestrians or cyclists to escape traffic is limited.
- 4. This is a popular cycle route.

Environment

- 1. This is a low-lying area and could cause issues with surface water drainage and pollution with run-off into the water ways.
- 2. There is an identified risk of flooding.
- 3. The trees, hedgerows and ditches have been identified as sites for bats, reptiles, breeding birds and great crested newts.
- 4. In this small community there are houses and gardens immediately bordering the proposed new site, which is incompatible with this proposal.

SUMMARY

The two sites are both unsuitable. The lack of local amenities and services will require increased road use. The lanes on which both sites are situated are narrow, with tight bends, and an increase of traffic will make them dangerous for other car users, pedestrians and cyclists.

In addition the lack of scrutiny of existing sites by the Council is of major concern, so that when rules are breached they are overlooked. When the Local District council have been alerted to these breaches by local residents (which has been the case since 2008), they appear to be unheard, contributing to the impression that local residents are voiceless in these consultations. Finally, the lack of notification and communication from the Local Council to residents about the consultations and plans is alarming.
